## BOROUGH COUNCIL MEETING MINUTES THURSDAY, APRIL 13, 2023, 7:00 PM COUNCIL CHAMBERS

**CALL TO ORDER:** This meeting was called to order at 7:00 PM by President Pompa.

**PRESENT:** A quorum was present including members of Council as follows: Joseph A. Pompa; Michele Baker; James Mielnik; Jeffrey Ketner; Walter Kalista, III; Brady Leahey; and Sean Burke. Also participating: Borough Manager James Gehret; Borough Secretary Patricia J. Duron; Mayor Joseph Dodson; Building Code Official Gerald Harbison; Solicitor Nathan W. Karn, Sr.; Chief Christopher Storm; and Director of Community Relations and Events Melanie Ramsey. Fire Marshal Amy Hazlett was absent.

**<u>PLEDGE OF ALLEGIANCE:</u>** President Pompa led the pledge of allegiance and a moment of silence.

**<u>MINUTES</u>**: The minutes from the meeting held on March 9, 2023 were presented for Council's review and approval. A motion to approve the minutes was made by Mr. Leahey and was seconded by Ms. Baker. A vote was taken and the minutes were approved, seven votes to zero votes.

**MANAGER'S/FINANCIAL REPORT:** Mr. Gehret advised that his reports were in Council's agenda binder. He added an update to the water line project in the Borough; advising that it should be completed by July.

**PLANNING/ZONING:** Mr. Harbison's report was in the council agenda. He advised that there will be a zoning hearing board hearing the week of April 16, 2023.

FIRE MARSHAL REPORT: Fire Marshal Amy Hazlett was absent.

- 2) **Two Certificates of Appropriateness** are to be Approved and Council Authorizes the Zoning Administrator to issue a Certificate of Appropriateness/Zoning Permit as follows:

## A. a. 309 ALLEGHENY STREET –BUSINESS SIGNAGE - DANIELLE NEWMAN

- Apply 12" gold vinyl lettering on an 8' sign board above the display window
- Apply 35" by 10" decal on the display windows
- This is a non-contributing structure within the Historic District

• The signage plan is compatible with zoning regulations per the district

# B. b. 513 MULBERRY STREET – REMODELING - 4 L's MANAGEMENT, LLC

- Get retroactive approval for replacing existing windows with double hung vinyl windows and replacing existing aluminum wrap on exterior windows
- Replace structurally compromised exterior doors with steel doors and wrap the exterior with aluminum
- A Zoning Permit is required
- This is a contributing structure within the Historic District

**STREET SWEEPER:** Mr. Gehret advised that the Borough is looking at various types of street sweepers.

**UPDATE ON DANGEROUS STRUCTURES AT 1100 FERN AVENUE AND AT 117 FRANKLIN STREET:** Mr. Harbison advised that the property at 1100 Fern Avenue will be sold soon and that the seller will rebuild there. There was consensus of Council Members to forego the hearing. A hearing will be scheduled for 117 Franklin Street.

PURCHASE ELECTRONIC SPEED SIGNS: Mr. Kalista made a motion to approve the

purchase of two electronic speed signs. Mr. Ketner seconded the motion and a vote was taken. The motion passed with seven votes in favor.
